# **Background**

Starting February 1st, 2024, under UMEED Expansion project, Population Foundation of India is scaling up family planning operations covering 50 %blocks across six districts i.e. Balrampur, Gonda, Sitapur, Barabanki, Unnao and Bahraich. In all, this scale up initiative will cover 47 blocks, 5,851 villages and impact the lives of nearly 1.25 crore people in the reproductive age group) 15-49 years. (All project interventions will focus on strengthening the existing public health system rather than creating parallel structures which are expensive to scale up and are not sustainable.

Population Foundation of India is implementing an Umeed Expansion project to catalyse faster improvements in the uptake of FP and SRH services by strengthening government public health systems, improving access to quality services and empowering woman especially young zero and low parity couples to make informed decisions on family planning and their well- being. The coverage areas of project will be 50 blocks across seven districts i.e. Balrampur, Gonda, Sitapur, Barabanki, Unnao, Bahraich & Shravasti. The major activities include:

- Setting up 1850 FP service corners in assigned the PHCs, CHCs and district hospitals in each district and visits the same public health facilities to support in well-functioning.
- Conducting trainings, meetings, cluster meetings and mentoring of CHOs ANMs and ASHAs to provide high quality FP methods, services and counselling at block levels.
- Organising campaigns, BCC activities and specials event and days block to district level to increase
  family planning awareness generation campaigns around early marriages, teenage pregnancy, the
  basket of contraceptive choices including new methods, ECP, medical abortions and male
  engagement.
- Handholding support from the Jan Aarogya Samiti's (JASs) at the PHC & SHC level for demand generation for FP services; enable utilisation of HWC untied funds local awareness generation activities and organise events to felicitate community champions, ASHAs, ANMs, CHOs and PRIs.
- To attend the meeting in the district health society, block coordination committee, district working group and others district & block level official's meetings

Population Foundation of India is seeking to engage an agency to facilitate the movement of staffs all through the districts. The purpose of this RFP is to solicit competitive proposals that meet our organization's transportation needs efficiently and effectively.



## **Scope of Work**

- Population Foundation of India is inviting proposal for hiring a taxi on daily and monthly basis in Balrampur, Gonda, Sitapur, Barabanki, Unnao, Bahraich & Shravasti districts, UP.
- Sedan (Etios or Dzire) and Brezza or compact SUV with gear [We will take Sedan for daily/monthly hiring but needs quotation for Sedan and Brezza for future use]
- Monthly rental basis including 2200 kms per month with the availability of vehicle and driver for maximum 26 days in a month. Extra KM and hours to will be charge additional.
- Daily hiring for 4 hours/40 kms and 8 hours/80 kms

The selected vendor will be responsible for providing Sedan/Brezza vehicle on a monthly/daily basis for a period of 1-year in the specified districts which can be extended based on their service quality and feedback from users. The vehicles will be required for various purposes, including but not limited to:

- Official trips within and outstation districts.
- Taxi will move within districts or outstation districts
- Carrying office and training materials
- Any other relevant transportation needs for office purpose

## **Proposal Guidelines**

Interested vendors are requested to submit their proposals in accordance with the following guidelines:

- Monthly fix charges should be for running up to 2200 kms/26 days in a month. Any usage beyond this will be charged extra.
- Daily hiring charges will be for 4 hours/40 kms and 8 hours/80 kms. Anything beyond that will be charged at extra km/extra hours.
- Vehicle to be provided shall not be registered earlier than 2017.
- Time and mileage are measured from Garage to Garage.
- Night charges and night timing should be mentioned.
- Vendor should allow to use hired vehicles for commuting across districts within UP.
- All inter district taxes, permit fees, tolls, MCD tax and Parking, etc., shall be extra as per actuals along with proofs/receipts.
- The agency needs to maintain a logbook/duty slip which shall be signed by the staff availing services and the same to be submitted by the vendor along with invoice.
- The vehicle offered shall be in good condition and must be air conditioned with all seat belts working.
- The driver provided with the car should be over 18 years, well experienced and carrying Driving License all the time.
- The vehicle and driver should be fixed and only in case driver goes on leave or car is sent for repair / service, a suitable replacement needs to be provided by the vendor.
- If required, the vehicle must provide on Sundays as well as on Holidays.
- All expenses related to vehicle and driver shall be borne by the vendor.
- All papers such as Registration Certificate (RC), Valid Insurance and Pollution Certificate etc must be in the vehicles provided to the organization.
- The vendor should be willing to provide vehicles with short notice.
- References from previous clients, preferably from organizations with similar transportation needs (if any).

#### **Evaluation Criteria**

Proposals will be evaluated based on the following criteria:

Cost-effectiveness and competitiveness of pricing.



- Availability of vehicles as per preferences shared.
- Ability to meet our organization's transportation needs efficiently.
- Experience and track record of the vendor in providing similar services.
- Availability and responsiveness to our organization's requirements.

## Documents to be submitted along with proposal

- Agency Profile: Provide details about your agency, including experience in providing vehicle rental services, number of vehicles, drivers and emergency contact details.
- Pricing: Clearly outline the fixed monthly rental cost, including the specified mileage.
- Statutory document of the agency such as Pan Card, Aadhar Card, GST Certificate, Bank Details and any other document in support to the proposal.
